Shri Amarnathji Shrine Board invites sealed tenders from reputed and registered Aviation companies having a fleet of a minimum of four helicopters or in a position to arrange a minimum of four helicopters for flight operations in the air space of J&K.

The flight operations are to be made for carrying Amarnathji pilgrims in sectors Srinagar - Holy Amarnathji Shrine- Srinagar and Baltal - Holy Amarnathji Shrine – Baltal for an initial period of three years roughly from 20th June 2007 to 30th August 2007 and similarly for the years of 2008 and 2009, depending on the dates for Raksha Bandhan (Shravan Purnima) in these two years.

Interested Aviation companies may furnish their offer containing tariff structure per passenger/(adult and child) and other terms & conditions for both sectors separately in two separate envelopes one containing technical/financial details and background of the company and the second containing the financial bid on the prescribed format covering all points of the tender document. The envelopes should be sealed separately and marked clearly as “Technical Bid” and “Financial Bid” . They can then be placed in a single bigger envelope and sealed. Failure to mark the two envelopes clearly may result in the opening of the financial bid prematurely . SASB reserves the right not to open the financial bid of any company which does not come upto the mark one technical grounds.

Tenders accompanied with a security deposit of Rs 10, 00,000/-(Rupees Ten lakhs only) in the shape of Bank Draft for each year of intended operation (e.g Rs. 30 lakhs for 3 years 2007, 2008 and 2009) in favour of **Chief Executive Officer, Shri Amarnathji Shrine Board, Raj Bhavan, Jammu-180001** shall be received by him on or before 1700 hours on 8th March 2007 and shall be opened on 9th March 2007 at 11:00 A.M in his office chambers in presence of such tenderers who may wish to be present.
