You are as such requested to kindly quote your rate in the bid for the Supply, Installation, Testing & Commissioning including 05 year of Comprehensive Maintenance period for the same giving full details including special discount to SMVDSB:

#### Terms and Conditions:

- 1. The proposal from the original manufacturer firms shall be preferred. However, the original manufacturer firm can nominate any representative/ distributor/ dealer for the institutional supply.
- 2. The interested firms/ distributor/ manufacturer/ vendors shall submit their techno commercial credentials for evaluation, reference and records.
- 3. The participating firms are advised to quote NET rates inclusive of all taxes, having special discount to SMVDSB & F.O.R. Engineering Store, Banganga. (Rates excluding GST & Ex-Shop shall not be considered even after opening of the quotation).
- 4. The overall cost of the entire equipments shall be considered and the order will be awarded to the firm whose total cost is less
- 5. Each bidder has to submit an Earnest Money in the shape of CDR/FDR pledged to FA/CAO, SMVDSB, Katra amounting to Rs.80,000/- (Rupees Eighty Thousand Only) only which shall be retained during rate contract period. However, the EMDs of the unsuccessful bidder (S) shall be released after issuance of supply order in favour of successful bidders.
- 6. Material shall be tested/checked from the consignment/lot by the committee of officers of Shrine Board and if found of inferior quality or not as per the specifications, Shrine Board reserves the right to terminate the Purchase Order and debarred the bidder/firm dealing with SMVDSB in future.
- 7. INSPECTION / LIFTING BACK OF REJECTED SUPPLIES:
  - a. On receipt, the material shall be inspected / checked by the officer/official of SMVDSB and if found of inferior quality/defective, the same will be rejected and Shrine Board shall be at liberty to have the same procured from open market at the risk & cost of the supplier whereby the original supplier shall be liable to pay the extra cost, if any, involved in the process. The Competent Authority, however, may accept the replaced material within the delivery period if it conforms to the approved specifications.

- b. The rejected material shall have to be lifted by the supplier at its own risk and cost within a week's time from the date of intimation (telephonic/written) falling which storage charges @ 2% per day of the total value of the material or as deemed fit to the authority shall be levied.
- c. Beyond one month of the intimation for lifting the material, the same shall be auctioned without any communication.
- 8. The maximum time for completion of the above said work shall be 60 days from the date of issuance of work order. In case of failure to complete the work within the stipulated period, the penalty shall be imposed as per following :
  - i. Up to 10 days: 01% of the work order value.
  - ii. 11 to 20 days: 02% of the work order value.
  - iii. 21 to 30 days: 05% of the work order value.
- iv. Beyond 30 days, the work order shall deem to be cancelled and the CDR/FDR of the supplier will be forfeited in favour of SMDSB, Katra by treating the work order as cancelled.
- 9. The Shrine Board reserve the right to negotiate the quoted rates, terms and conditions with the lowest bidders or any of the other bidders on quality basis to ascertain the suitability of the acceptable offer.
- 5. The Shrine Board reserves the right to split the demand among one or more qualified bidders at the approved rate after culmination of successful RFIQ.
- 6. The Shrine Board reserves the right to select or reject any brand /item and the firm cannot claim any reason whatsoever of any kind in selection of procedure being adopted.
- 7. The Competent authority of SMVDB reserves the right to:
  - a) To cancel/ terminate the RFIQ/ supply order / during the period of its validity without assigning any reason thereof.
  - b) To forfeit the CDR/FDR of defaulter supplier.
  - c) Debarring any defaulter from any further dealing with Shrine Board.
  - d) Grant of extension with or without imposing penalty, as deemed fit.
- 8. Conditional, illegible, ambiguous quotation (s) and quotation (s) received after the stipulated date and time shall be out rightly rejected.
- **9. Comprehensive Maintenance:** The successful bidder shall be full responsible for rectification of all defects (free of cost) during 05 years of Comprehensive Maintenance period reckoned from the date of successful completion of defect liability period. The defects arising if any shall be rectified by the supplier within a period of 24 hours. In case of the failure to do so within specified time frame, the SMVDSB shall be at liberty to impose penalty for the same.

#### 10. Payment Terms:

All the payment shall be released after due certification by the Engineer Incharge of SMVDSB nominated by the competent authority as per the following;-

- i. 50% amount shall be released after receipt of the consignment of material at Engineering Store, Banganga Katra within a period of 15 days from the date of issuance of G.R.
- ii. 40% amount shall be released after successful Installation, Testing & Commissioning of equipment at site.

- iii. Balance amount of 10% shall be paid in 05 equal installments by the end of every year during the Comprehensive Maintenance Period of 5 years or against the Bank Guarantee of equivalent amount extendable up to 05 year.
- 11. The quantities can be increased / decreased substantively according to the requirement of SMVDSB.
- 12. Donations to Shri Mata Vaishno Devi Shrine Board, Katra are exempted from Income Tax under Section 80-G of the Income Tax Act.
- 13. The other standard and terms and conditions of the contract shall be notified separately to the successful bidder and will incorporate in the contract/supply order.
