Terms & Conditions: -

1. This is only an enquiry and not a purchase order.
2. Quantity mentioned is indicative in nature.
3. The rate quoted shall remain valid of a period of 07 days from the last date of the submission of quotation.
4. The rates quoted shall be net FOR Non-Engineering Store, Banganga (Katra) inclusive of GST/other charges.
5. The successful firm shall have to deliver the ordered material within a period of 20 days from the date of issuance of supply order.
6. **PENALTY:** Following penalties shall be imposed after delay beyond the delivery period, subject to acceptance by the Competent authority of SMVDSB:-
  - a) upto 7 days @ 0.5%
  - b) From 8<sup>th</sup> day to 15<sup>th</sup> day @ 1%
  - c) From 16<sup>th</sup> day to 22<sup>nd</sup> day @ 1.5% and
  - d) From 23<sup>rd</sup> day to 30<sup>th</sup> day @ 2% shall be imposed on each pending item as per the approved rate/quantity mention in the purchase order of the value of the pending supplies.
  - e) Further delay shall attract penalty @1% every 10<sup>th</sup> day.

- f) In case of incomplete supply received, an amount equal to 2% of the total value of non-supplied material shall be deducted from the due payment of the supplier.
7. The Competent authority of SMVDSB reserves the right to:-
- To cancel/ terminate the supply order during the period of its validity without assigning any reason thereof.
  - Debarring any defaulter from any further dealing with Shrine Board.
8. Donations to Shri Mata Vaishno Devi Shrine Board, Katra are Exempted from Income Tax under Section 80-G of the Income Tax Act.
9. Other standards, terms and conditions will be incorporate in the Supply order of the successful bidder.
