Terms and Conditions:

- 1. This is just a RFIQ and not a Purchase Order.
- 2. Rate should be NET inclusive of all taxes, FOR Non- Engineering Stores, Banganga (Katra) and entailing special discount to SMVDSB. The interested firms to also please note that the donations made to Shri Mata Vaishno Devi Shrine Board, Katra are exempted under Section 80-G of the Income Tax Act.
- 3. The quotation should be valid for a period of 10 days from the date of Opening. Further, the offered rate should be valid for a period of Three Month from the date of issuance of Rate Approval Order / Purchase Order.
- 4. You are requested to send your quotations by or before 30.12.2024 upto 05:00PM. Quotations received after due date and time shall not be considered.

5. The participating firm shall have to submit prescribed test certificates as per FSSAI/BIS (IS5982 and IS498), without which the offer submitted shall not be considered.

6. The supplier has to mention the price of the material, CGST & SGST separately while raising the bills of supplies.

7. The quantities mentioned in the format are indicative in nature and can be increased / decreased substantively according to the requirement from time to time during the rate approval period.

8. Shrine Board Reserves the right to split the demand among one or more firms on quality basis to ascertain the suitability of the acceptable offer.

9. Shrine Board Reserves the right to cancel the RFIQ without any prior notice.

10. No Advance payment shall be made. The payment shall be made and after receipt and proper inspection of complete material at Non Engineering Store, Banganga.

11. The Shrine Board reserves the right to negotiate the quoted rates, terms and conditions with the lowest bidder or any of the other bidder on quality basis to ascertain the suitability of the

acceptable offer.

12. On receipt, the material shall be inspected / checked by our Inspection Committee and if found of inferior quality/defective, the same will be rejected and the Board shall be at liberty to have the same procured from open market at the risk & cost of the supplier whereby the original supplier shall be liable to pay the extra cost, if any, involved in the process. The Competent Authority, however, may accept the replaced material within the delivery period if it conforms to the approved specifications.

13. In case of failure to supply the marterial, within the stipulated period, the following penalties (calculated on the value of unsupplied material) shall be imposed for delay beyond the prescribed delivery period, unless exempted by the competent authority for valid reasons to be brought on

record subject to acceptance by the Competent authority of SMVDSB:-

a) upto 7 days @ 0.5%

b) From 8th day to 15th day @ 1% c) From 16th day to 22nd day @ 1.5% and

d) From 23rd day to 30th day @ 2% shall be imposed on each pending item as per the approved rate/quantity mention in the purchase order of the value of the pending supplies.

e) After 30 days of delay, the purchase order shall be deemed to have been cancelled to the extent of unsupplied material and the material shall be procured from alternative sources at risk and cost of the vendor.

Note: Despite of cancellation of Purchase Order as stated above; for any valid reason to be brought on record, the Competenr Authority may grant extension in the stipulated delivery period; with or without penalty. (Amount to be decided by the competent Authority).

14. The successful bidder shall have to submit the laboratory test report along with each

consignment.

15. The Shrine Board reserves the right to reject, accept or prefer any quotation in part or full at any stage if not in conformity to the quality, terms & conditions mentioned in the RFIQ. Shrine Board also reserves the right to re-invite the RFIQ at its sole discretion.

16. Conditional, illegible, ambiguous quotation(s) and quotation(s) received after the stipulated date and time shall be out rightly rejected.

17. Others Standing terms and conditions shall be incorporated in the supply orders of the successful bidders.
