CORRIGENDUM

Pre-bid conference for e-NIT No. CO/Cat/401/454 dated: 01.07.2024 for allotment of Shop No.64, Shopping Complex, Bhawan was held on 05-07-2024 at SGC, Katra to address the queries of prospective bidders.

Pursuant to the deliberation by the committee and decision by the Competent Authority regarding queries submitted by the prospective bidders, the following changes shall be deemed to have been incorporated in the e-NIT:

S. No	Queries of the prospective bidder	Clarifications
1.	Cumulative sales turnover be considered upto 2022-23 instead of 2023-24 on the grounds that some of the firms has yet not filed their Returns whose timeline is upto ending September 2024.	The cumulative sales turnover of the prospective bidders for last three financial years both upto 2022-23 and 2023-24 shall be considered.
2.	For complimenting the clauses of Principal company with distributor/ franchisee.	Additional Clause has been incorporated in Clause 3 (II) of the E-NIT as per the following: <i>“The distributor / authorized franchisee should also furnish supporting documents of Principal company validating the conditions given at Clause 3, (I) except Clause 3 (I) d.”</i>
3.	For incorporating Oath Commissioner alongwith 1 st Class Magistrate in the conditions of the e-NIT.	Attestation from the Oath Commissioner shall also be considered alongwith 1 st Class Magistrate/ Judicial Magistrate in Instructions to bidder at S.No. 15, Clause 3 I (c) & 3 II (c) and Schedule-A (S.No. 03, 10 & 17) of the e-NIT.
4.	Can the Board relax the financial conditions of the e-NIT by reducing the sales turnover of distributor / franchisee from 20 crore to 10 crore. Besides, can the Board altogether relax the financial conditions and shortlist the bidder on the criteria of presentation of the services being offered by the bidder?	There shall be no change in the financial conditions of the E-NIT.
5.	Can the Clause-56 of the e-NIT which binds the bidder for Sale of food and beverage items termed as Yatri Menu on the rates approved by the competent authority of the Shrine Board be eliminated.	Yatri Menu shall remain intact in the e-NIT with an approach to promote inclusivity alongwith well being of pilgrims as per the practice in vogue.
