up an Incident Command Center (with LED Screens) at Katra for a period of 1 Years with a provision for an extension of another one year on the same Rates & Terms

The Sealed Quotations addressed to the Jt. Chief Executive Officer (S), Shri Mata Vaishno Devi Shrine Board shall be submitted in person in the Receipt and Dispatch Section of SMVDSB at Central Office, Katra or by email at jtceos@maavaishnodevi.net by or before 05.04.2024 upto 03:00 PM positively.

The Quotations will be opened on the same day or any other day convenient to the authority. The representatives of bidders can attend the same, if desirous so.

1. This is only an enquiry and not a purchase order.

- 2. The Service Provider shall quote the rates offered as per Performa enclosed at **Annexure-A**. No change in the enclosed Performa shall be allowed.
- 3. The list of locations where the cameras are required to be installed with type are placed as **Annexure-'B'**
- 4. The Service Provider should create an integrated network of CCTV cameras with One Control centre at Police Station, Katra and One Control Centre at SGC, Katra.
- 5. All the allied works (Civil/Electrical/Mechanical) related to the CCTV Surveillance shall be in the scope of Service Provider. Electricity connections for the proposed CCTV cameras shall be arranged by the Service Provider from their own resources.

- No extra payment shall be made for allied equipment and related electrical connections.
- 7. The Service Provider has to arrange a suitable platform for installation of CCTV cameras at designated public places from his own resources.
- 8. The installation is temporary. The Successful bidder can take away the CCTV and allied installed equipment after the completion of the **Special Occasions** and peak period of Yatra Pilgrimage.
- 9. Clarifications can be sought by sending emails at the given email id before one day of the bid submission closing date.
- 10. The rates quoted by the Service Provider should be net inclusive of all taxes including GST and full & final and shall not be revised during the Contract Period. No claim, whatsoever of any reason shall be entertained during the period of contract.
- 11. The validity of the Quotation shall be 30.04.2024.
- 12. Conditional, illegible, ambiguous quotations and quotations received after the stipulated date and time shall be out rightly rejected. Quoting unrealistic rates will be treated as disqualification.
- 13. The SMVDSB is at liberty to cancel the Order/Contract at any stage during the Contract Period in case of unsatisfactory performance by the Service Provider.
- 14. The Shrine Board reserves the right to cancel the RFIQ without any prior notice.
- 15. The Shrine Board reserves the right to reject, accept or prefer any Offer in part or full without assigning any reason whatsoever in this regard. The Shrine Board also reserves the right to re-invite the Quotations solely at its own discretion.
- 16. The Competent Authority of SMVDSB Reserves the right to terminate the Contract during the period of its validity without assigning any reason thereof.
- 17. Any of the parties may apply to the Chief Executive Officer of Shri Mata Vaishno Devi Shrine Board for the appointment of the Arbitrator in the event of any dispute/difference. On receipt of such requests, it shall be lawful for the Chief Executive Officer to appoint an arbitrator to adjudicate upon the dispute/differences.
