**Instruction to Bidders regarding e-Tendering process:**

1. The interested bidder can download the e-NIT/bidding document from the website [www.jktenders.gov.in](http://www.jktenders.gov.in) & [www.maavaishnodevi.org](http://www.maavaishnodevi.org).
2. To participate in bidding process, bidders have to get Digital Signature Certificate (DSC) as per Information Technology Act-2000, to participate in online bidding. This certificate will be required for digitally signing the bid. Bidders can get above mentioned digital certificate from any approved vendors.
3. The Bidders, who already possess valid (DSC) Digital Signature Certificates, need not to procure new Digital Signature Certificate.
4. The bidders have to submit their bids online in electronic format with Digital Signature. The bids cannot be uploaded without Digital Signature. No Proposal will be accepted in physical form.
5. Bids will be opened online as per time schedule mentioned in the e-NIT.
6. Before submission of online bids, bidders must ensure that scanned copies of all the necessary documents have been attached with bid.
7. The SMVDSB will not be responsible for delay in online submission of bids whatsoever reasons may be.
8. All the required information for bid must be filled and submitted online.
9. The details of cost of documents, EMD specified in the tender documents should be the same, as submitted online (scanned copies) otherwise bid will not be accepted.
10. Bidders are advised to use “My Documents” area in their user on <http://jktenders.gov.in>, e-tendering portal to store important documents like Balance sheet, GST Registration Certificate, Tax Clearance Certificate, IT

certificate, and other related documents etc., and attach these certificates as Non-Statutory documents while submitting their bids.

11. Bidders are advised not to make any change in BOQ (Bill of Quantities) content or its name. In no case they should attempt to create similar BOQ manually. The BOQ downloaded should be used for filling the item rate as prescribed and it should be saved with the same as it contains.
12. Bidders are advised to scan their documents at 100 DPI (Dots per Inch) resolutions with Black and White, PDF \ Scan properly.

The bidder must satisfy the following technical criteria:

## 5. **PROCEDURE FOR SUBMISSION OF TENDER:**

Bidders are invited to submit Bids for “**e-Notice Inviting Tender (e-NIT) for for afforestation activities using aerial seed dispersal technology i.e. through drone**” for “**Shri Mata Vaishno Devi Shrine**” in two parts viz. Technical Bid (**Annexure-‘A’**) and Financial Bid (**refers to BOQ Online only**) as per enclosed proforma along with supporting documents, application fee, EMD etc. The Tenderers are required to submit their tenders under 2 bids system with Cover-I (Technical Bid) and Cover-II (Price Bid).

### A. **Cover-I (Technical Bid):**

- (i) **Annexure-‘A’** form duly filled in along with relevant documentary proofs.
- (ii) Scanned copies of EMD in shape of CDR/FDR pledged to FA/Chief Accounts Officer, SMVDSB.
- (iii) Tender Fee of **Rs.500/-** either in the form of DD pledged to FA/Chief Accounts Officer, SMVDSB, Katra or shall be deposited in the official account of Shri Mata Vaishno Devi Shrine Board, Branch J&K Bank Katra, Account No. 0235040500001804, IFSC – JAKA0KATTRA (in IFSC Code JAK0KATTRA – 0 stands Zero). The bidder shall mention UTR No. in the prescribed Technical Bid Form at Annexure- ‘A’.
- (iv) Tender Document containing Instructions, Terms and Conditions duly signed on each leaf by the Tenderer, along with documentary proof wherever required.

### B. **Cover II (Price Bids):**

- (i) Price bid shall contain price quoted for each work separately as per BOQ & has to be submitted **online** in the form of BOQ only.
- (ii) The price bid should be absolute and unconditional.
- (iii) Conditional bids shall be rejected.
- (iv) The price bid shall be opened in favour of bidders who qualify in the technical bid. Rates are required to be quoted strictly as per prescribed BOQ / item of works.

(v) Price bids not conforming to above standards or suffering from any flaw shall be rejected.

**6. PRE-BID CONFERENCE:**

A pre-bid conference will be held on **18-06-2025 at 11:00AM** at office chamber of ACF, SMVDSB, Katra. It is advised that before Pre-bid meeting, the bidder shall visit the site to acquaint themselves with the prevailing condition and other facilities available nearby. Conceptual understanding / layouts of area whichever possible will be provided to bidders during pre-bid meeting or any other query of the interested firm regarding the project shall be consulted with the authority. **Shrine Board reserves the right to modify the terms & conditions of e-NIT after the pre-bid conference in view of any practical modalities which may emerge during the pre-bid meeting.**

**7. EARNEST MONEY DEPOSIT:**

- I. The Bidders should submit an EMD of **Rs. 30,000.00 (Thirty Thousand only)** in the form of CDR/FDR pledged to the FA/ Chief Accounts Officer, Shri Mata Vaishno Devi Shrine Board, Katra. There shall be no relaxation/ concession to any Unit/Agency whatsoever in regard to the amount of EMD to be paid.
- II. EMD should be included along with the Technical Bid in the cover containing Technical Bid as the Technical Bid will be opened first. The Bidders should NOT include EMD in the cover containing Financial Bid. If the EMD is not found in the cover containing Technical Bid, the tender will be rejected.
- III. Tenders received without enclosed EMD in the cover containing Technical Bids will be summarily rejected. EMDs other than in the form of CDR / FDR will not be accepted and the tenders with EMD in the form of other than CDR / FDR Draft will be summarily rejected. The EMD will not bear any interest. The Shrine Board will not entertain any request for adjusting the EMD from the tender due/running bills or from the EMD/Security Deposit of for any other Bidders. In case of withdrawal of tender by the Bidders within the Validity period of the offer or before finalization of the order, the EMD amount paid will be forfeited.
- IV. The Earnest Money of the Bidders shall be forfeited if they withdraw their tender or raise the price of their offer within the validity period. The Earnest Money shall also be forfeited in case of Bidders who do not comply with purchase order placed on them within the validity period of offer or violate any terms and conditions contained herein, for this purpose purchase order shall be deemed to have been placed from the date of letter of intent.
- V. EMD of the unsuccessful bidders shall be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30<sup>th</sup> day after the award of the contract Clause-170(ii) of GFR-2017.

**8. SELECTION CRITERIA:**

All bidders shall submit documentary proof in support of meeting Eligibility Criteria. In the first stage of evaluation, Proposals shall be rejected, if found deficient as per the requirements of e-Tender/Bid Processing Fee and other eligibility criteria.

Only bids confirming the e-NIT conditions shall be further taken up for evaluation. The only bidder(s) qualifying the technical evaluation criteria shall be entitled as competent for the process of financial bid evaluation. The participating bidder's criteria eligibility shall be evaluated on the basis of points to be obtained in the point matrix.

**B. The Bidding Process**

Bidders who qualify the minimum eligibility criteria will be only consider for next Technical Evaluation and Minimum 25 (Twenty-Five) marks is required out of the total Technical Score of 100 for getting short listed for opening the Financial Bid.

**9. THE SCOPE OF WORK SHALL INCLUDE THE FOLLOWING:**

- a. Subject to the terms and conditions of an Agreement, SMVDSB shall engage UAV operators to operate Beyond Visual Line of Site (BVLOS) in fixed pre-defined / pre-approved flight paths and dispersal seeds in order to create afforestation on the Trikuta Hills at selected locations in SMVDSB Jurisdiction and return to the base camp. The UAV operator shall be responsible for



establishing, installing, operating, and maintaining UAV based system and associated logistics for the dispersal of seeds. Also, the UAV operator must adhere to safety guidelines and the latest regulations Drone Rules 2021 by Govt. of India for operating UAVs.

- b. The service provider will be expected to dispersal the seeds to and from remote areas that are not well connected through regular transportation networks.
- c. The services to be provided are purely non-commercial in nature and will only apply for purposes to create afforestation in the ecosystem.
- d. **Site: TRIKUTA HILLS of SMVDSB (J&K).**
- e. **Objective: To implement the drone-based dispersal of seeds at hard-to-reach terrains of the mountains of Trikuta Hills (J&K).**
- f. **Estimate Flights: 250**
- g. **Seeds / Seedball will be provided by Forest Wing, SMVDSB.**
- h. **The flight of the drone shall only be considered if it takes the time of minimum 8 min only for the purpose of the dispersal of seeds.**

#### **10. THE SCOPE OF SHRINE BOARD:**

Electricity shall be provided by the Shrine Board at one point for the charging of the batteries.

#### **11. SPECIFICATIONS OF DRONE:**

Considering location and environment of Aerial Seeding we are inviting bidder who has experience to perform Aerial Seeding activity in high gust environment. Project locations are located between 1000 to 5000 feet (above sea level).

- Payload Carry Capacity: 5-10Kg
  - Flight Time: minimum 18 minutes as per datasheet
  - Battery Capacity: 22000 mAs per datasheet
  - Seed Dispersal Technology (required add-on mechanism):
- a. Drone with counting system mechanism and capable of dropping individual seedball as per command
  - b. Able to carry and drop mass seedballs of 20-40 mm
  - c. Compatible mechanism to disperse seeds evenly
  - d. Drone must have Mapping stick with drone to get the exact location and precision in work.

#### **12. GENERAL TERMS & CONDITIONS:**

- I. That work allotted to the firm shall be up to the completion of the flights of the aerial Seeding.
- II. The time for completion of the work shall be for a period of 30 days reckoned from the date of issuance of LOA.
- III. The firm shall have to make payment on account of any loss/damage caused to the property of the Shrine Board by his workers intentionally or un-intentionally, failing which the same shall be recovered from his due payment/Security Deposit of firm.

- IV. Accommodation to the Supervisor and operators shall be provided by the Shrine Board on payment basis if required.
- V. The Security Deposit shall be forfeited if the firm prematurely withdraws or if the services are terminated for being unsatisfactory.
- VI. That the firm shall solely be liable for any costs, charges or expenses arising out of any claims or legal proceedings in connection with or relating to its operation/activities under this agreement. The Firm shall be liable to indemnify and keep indemnified the SMVD Shrine Board against any damages, compensation, costs, charges or expenses arising out of any claims or proceedings relating to its operations/activities.
- VII. That the firm shall continuously maintain adequate protection of all the materials and equipment from damages, destruction or loss and shall also protect the property of the SMVD Shrine Board from any damage.
- VIII. That if it is observed during bidding process/bids evaluation stage that a bidder has indulged in corrupt/fraudulent/collusive/coercive practice, the bid of such Bidder(s) shall be rejected and its Earnest Money Deposit (EMD) shall be forfeited. Further, such agency shall be debarred for future business with Shrine Board for a period of next five years.
- IX. That the firm shall ensure that its employees/workforce maintain the sanctity of Shrine and shall not indulge in any activity which is prejudicial to the interest of the Holy Shrine. **Staff of the firm shall not indulge in smoking or consumption of liquor/alcohol or consumption of any non- vegetarian food articles.** They shall maintain proper decorum and discipline, and ensure proper conduct in speech and dress. They shall also refrain from any other activity which might hurt the sentiments of pilgrims.
- X. That the work performance shall be continuously monitored and evaluated by concerned Incharge, Forester.
- XI. Each worker of the agency must possess and carry ID Card mentioning the Aadhar number on the card.
- XII. Staff must maintain & ensure utmost personal hygiene & etiquette and manners.
- XIII. The firm shall be responsible for behavior and conduct of his workers. No workman with doubtful integrity of having bad record shall be engaged by the firm.
- XIV. The firm shall have to ensure that information provided to it as part of this contract/agreement shall be kept confidential, secure and protected.
- XV. After LOA the firm will share the list of staff including experience / skilled worker certificate and the person in list may present demo in front of designated committee.
- XVI. The Chief Executive Officer/Addl. Chief Executive Officer, SMVDSB reserves the right to accept or reject any one or all the tenders without assigning any reason thereof.

### **13. PENALTY CLAUSE:**

- i. **Equipment Failure** : If the drone equipment fails to operate as specified, resulting in reduced efficiency or effectiveness, a penalty of 2% of the total

contract value per incident will be imposed, up to a maximum of 5% of the total contract value.

- ii. **Safety and Security:** If the service provider fails to comply with safety and security regulations, resulting in accidents or damage to property, a penalty of 10% of the total contract value will be imposed.
- iii. **Data and Reporting:** If the service provider fails to provide accurate and timely data and reports, a penalty of 1% of the total contract value per day of delay will be imposed, up to a maximum of 5% of the total contract value.

#### **14. PERFORMANCE SECURITY:**

- (i) The successful bidder shall furnish performance security equivalent to 5% (**five percent**) of the total value of the contract, in the form of Bank Guarantee from any Nationalized / Scheduled Bank pledged to the Chief Accounts Officer, SMVDSB, Katra within the stipulated period of 07 days from the issuance of Letter of Award. Failure to do so within the stipulated period, the contract shall be liable for cancellation together with forfeiture of the Earnest Money Deposit (EMD).
- (ii) If the bid of the successful bidder is seriously unbalanced in relation to the Engineer's Estimate of the cost of work to be performed under the contract, the Board may require the Bidder to produce detailed price analysis for any or all items of BoQ, to demonstrate the internal consistency of those prices. After evaluation of the price analysis, the Board may require that the amount of performance Security set forth in clause 20 (i) in of this tender be increased at the expense of the successful bidder under the contract. The amount of increased performance security shall be as under:

**15. PAYMENT TERMS:**

- A. The payment shall be released in favour of the firm only after receipt of **Satisfactory Performance Reports** in all respects duly authenticated by the Committee constituted. The performance of the firm shall have to be of the highest order. The Committee constituted shall give the satisfactory performance report only after the firm has exhibited the work as per the desired quality parameters.
- B. Bidder has to quote overall rate for project including all taxes and for rate contract fill the price including all taxes per flight in given annexure-1.

**16. TERMINATION OF CONTRACT:**

- i. The Chief Executive Officer/Addl. Chief Executive Officer, SMVDSB reserves the right to terminate the tenders at any point of time without assigning any reason thereof.
- ii. The contract shall also be terminated, if the Successful bidder fails to take-up the work or execute the agreement with SMVDSB in the stipulated time or fails to deliver / non-compliance as per the terms & conditions of the e-NIT.

**17. ARBITRATION:**

In case of any dispute arising between the parties to this e-tender and all matters connected therewith, both parties shall make every effort to resolve it amicably by direct informal negotiation. If even after thirty days from the commencement of informal negotiation, the parties have not been able to resolve the dispute amicably, then such disputes/differences shall be resolved by Arbitration as per the Arbitration and Conciliation Act, 1996.

- 1. Either party may request other of its intention that a dispute be submitted to Arbitration and both the parties shall meet within 15 days from the date of receipt of such request to select a sole arbitrator mutually for the resolution of dispute and venue / seat or Arbitration shall be at Jammu / Katra / Reasi.
- 2. In the event that the parties cannot agree upon the selection of the sole Arbitrator, either party or both the parties may move an application before the Hon'ble High Court at Jammu, under the Arbitration and Conciliation Act, 1996, for the appointment of sole Arbitration with seat/venue at Jammu for the resolution of dispute between the parties.

**18. ALLOTMENT OF THE WORK / CONTRACT, IN CASE OF TERMINATION OF CONTRACT/ WORK ORDER SITUATION ARISES:**

- a. The Earnest Money Deposit shall be forfeited, if the successful Bidder fails:
  - 1. To accept Letter of Award
  - 2. To furnish Performance Security Deposit in accordance with Clause No. 19 of the e-NIT.
  - 3. To take-up the work or execute the agreement with SMVDSB in the stipulated time.

- b. Termination of Contract during the currency of the contract period due to whatsoever reasons.
- c. **Shrine Board reserves the right to alter, accept or reject part or all the Tenders without, assigning any reason thereof.**

**19. FORCE MAJEURE:**

If during the currency of Contract, there is any out-break of war / natural calamity or any such reason, which whether financially or otherwise affects the execution of the Contract the firm (unless contract is terminated) under provision of this Clause shall make his / her best efforts to complete the Contract. However after outbreak of such war / natural calamity or any such reason, Shri Mata Vaishno Devi Shrine Board shall be entitled to terminate the Contract at any time by giving notice in writing. Force Majeure is hereby defined as a 'Clause' which is beyond the control of SMVDSB / Firm and which consequently affects the performance of the Contract.

**20. JURISDICTION:**

Court of Reasi & Katra alone shall have the jurisdiction with respect to the subject matter of this contract.

**21. PERMITS & LICENSES:**

All licenses and permits for the work under Government control (local/Central) authorities shall be obtained by the Bidder himself at his own costs and fees.

**22. VALIDITY OF RATES:**

The rates quoted by the bidders shall be valid for a period of 6 months (Six months) from the issuance of rate contract or till new rate contracts are finalized by SMVDSB.
